

RESOLUTION NO. 2024-09

**A RESOLUTION OF THE TOWN OF BAR NUNN ACKNOWLEDGING AND
ACCEPTING BEING NAMED AS THE OWNER OF RECORD ON THE
CERTIFICATES OF APPROPRIATION FOR:**

PERMIT NO. 30386

O.R. 51, P. 425; C.R 82, P. 11; PROOF NO. 35593,

AND

PERMIT NO. 6101

O.R. 51, P. 425; C.R 82, P. 10; PROOF NO. 25409;

WHEREAS, pursuant to the dissolution of the Wardwell Water & Sewer District in accordance with Wyo. Stat. Ann. §§ 22-26-401-408, the ownership and operation of the District, in its entirety, is being transferred, assigned, and changed to the Town of Bar Nunn; and

WHEREAS, The Town of Bar Nunn has assumed the role formerly occupied by the Wardwell Water & Sewer District for the provision of water and sewer utilities to the customers located in the Wardwell Water & Sewer District; and

WHEREAS, The Town of Bar Nunn acknowledges that the Wardwell Water & Sewer District is the owner of record of two appropriations, which are described as:

1. Casper Water Treatment Plant No. 1 Intake, Permit No. 30386, adjudicated under Proof No. 35593, in the amount of 3.2 cfs diverting from the North Platte River through the Casper Water Treatment Plant No. 1 Intake, with a priority of October 19, 1981, and of Order Record 51, page 425, Certificate of Record 82, page 11, for municipal purposes within the Central Wyoming Regional Water System (CWRWS) Service Area
2. Casper Water Treatment Plant No. 1 Intake, Permit No. 6101, adjudicated under Proof No. 25409, in the amount of 77.42 acre feet at a rate not to exceed 0.56 cfs during a period from May 1 to September 30 of each year, diverting from the North Platte River through the Casper Water Treatment Plant No. 1 Intake, with a priority of July 7, 1904, and of Order Record 51, page 425, Certificate of Record 82, page 10, for municipal purposes within the CWRWS Service Area.

WHEREAS, The Town of Bar Nunn is aware that pursuant to the dissolution process and statutory requirements, the Wardwell Water & Sewer District, jointly with the Central Wyoming Regional Water System Joint Powers Board, petitioned the State of Wyoming State Board of Control for issuance of Amended Certificates of Appropriation for the afore-described appropriations; and

WHEREAS, Prior to filing of the Petitions with Wyoming State Board of Control, the Town of Bar Nunn reviewed both Petitions for the issuance of Amended Certificates of

Appropriation for the Wardwell Water & Sewer District Appropriations Under Permit No. 6101 and Permit No. 30386; and

WHEREAS, The Town of Bar Nunn approves of the Petitions, in full, consents to the filing of the Petitions, and consents to the Town of Bar Nunn being the owner of record for both Permit No. 6101 and Permit No. 30386 with the express understanding that it is for water use for municipal purposes within the service area of the Town of Bar Nunn.

WHEREAS, The Town of Bar Nunn was advised that the Wardwell Water & Sewer District, jointly with the Central Wyoming Regional Water System Joint Powers Board, filed the two Petitions for the issuance of Amended Certificate of Appropriation for the Wardwell Water & Sewer District Appropriations Under Permit No. 6101 and Permit No. 30386, as described above, with the State Board of Control for the State of Wyoming, wherein it was requested that the owner of record for both certificates of appropriation be amended and changed from the Wardwell Water & Sewer District to the Town of Bar Nunn; and

WHEREAS, The State Board of Control conditionally granted approval of both Petitions on February 6, 2024, on the condition that the Town of Bar Nunn provide express consent, agreement, and acknowledgement to, for the Town of Bar Nunn to be identified as the owner of record for the appropriations under Permit No. 6101 and Permit No. 30386; and


WHEREAS, The Town of Bar Nunn hereby provides express consent, agreement, and acknowledgement to, for the owner of record for the afore-described appropriations under Permit No. 6101 and Permit No. 30386 is changed from Wardwell Water & Sewer District to Town of Bar Nunn.

NOW, THEREFORE, The Town of Bar Nunn, Wyoming, through its Governing Body, hereby acknowledges and accepts the Town of Bar Nunn being named as the Owner of Record on the Certificates of Appropriation for Permit No. 6101 and Permit No. 30386, as more specifically described above and in the Petitions for Amended Certificates of Appropriation.


